Suite of mobile apps makes taxes on-the-go easier and more convenient than ever

Designed for the millions of hard-working Americans with a simple tax return (1040EZ/A), <a href="SnapTax">SnapTax</a> lets users prepare and e-file their federal tax return anytime, anywhere, for free. Now bilingual taxpayers can easily and accurately prepare and e-file their taxes entirely in Spanish or, with a quick tap in the settings menu, switch between English and Spanish. So customers never feel alone, TurboTax provides direct access to bilingual credentialed tax (all CPAs and enrolled agents) and product experts who are available by phone for free to all mobile customers in their preferred language.
