As a result of these reorganizations, costs associated with these functions are no longer included in segment operating income and are now included in other corporate expenses. For FY'24, we reclassified expenses totaling \$1.4 billion from Global Business Solutions, \$573 million from Consumer, and \$33 million from Global Business Solutions, \$475 million from Consumer, and \$34 million from ProTax to other corporate expenses.
