- 2. Stock bonus settles only to extent vested and only in stock and automatically vests in 225,000 shares on 7/31/2006 if reporting person is continuously employed by issuer through vesting date; thereafter, 85,000 shares vest on each of 7/31/2007 and 7/31/2008, provided reporting person is continuously employed by issuer on such vesting dates; vesting may be partially accelerated if employment terminates in certain circumstances and fully accelerated if employment terminates following a change in control.
- 3. Shares subject to the award that have vested will be settled in shares on the first day of the fiscal year following the date that the reporting person ceases to be both the CEO of issuer and a covered employee as defined in Section 162(m)(3) of the Internal Revenue Code. Reporting person may elect to settle earlier on up to 50% of the shares subject to the award, but shares will be issued only to the extent the award has vested.
